#### COSTA RICA

#### Conditional Initial Offer

The following communication, dated 1 April 2004, from the delegation of Costa Rica is being circulated to the members of the Council for Trade in Services.

#### Introduction

1. Pursuant to Article XIX of the General Agreement on Trade in Services (GATS) and paragraphs 7 and 15 of the Doha Ministerial Declaration on the negotiation of specific commitments and the submission of initial others within the framework of the GATS, Costa Rica hereby submits its conditional initial offer of specific commitments in services and its list of exemptions to most-favoured-nation treatment.

2. Costa Rica points out that this is a conditional initial offer, subject to the progress made and agreements reached in the framework of negotiations under the Doha Work Programme and in the Council for Trade in Services and its subsidiary organs. It therefore reserves the right to revise, modify or supplement this offer, including technical revisions or modifications, at any time prior to the conclusion of the negotiations in the WTO.

3. For the preparation of this initial offer of specific commitments, Costa Rica based itself on the Services Sectoral Classification List (MTN.GNS/W/120).
