### **REQUEST FROM THE EC AND ITS MEMBER STATES (HEREAFTER THE EC)**

#### **TO**

#### **MEXICO**

#### **GENERAL REMARKS**

At the WTO Ministerial Conference in Doha in November 2001, Ministers agreed that initial requests for specific commitments should be submitted by 30 June 2002.

In line with this decision, and committed to the objectives and principles stated in the GATS, in particular Article IV and XIX GATS, as well as the negotiating guidelines agreed by the Council for Trade in Services on 29 March 2001, the EC encourages Malaysia to participate actively in the negotiations.

The EC consider that the progressive liberalisation of services is of benefit for all members, including developing and least developed countries. The EC recognises the importance of liberalisation being underpinned by domestic regulatory frameworks designed to ensure the achievement of public policy objectives.

This request covers horizontal commitments and the following service sectors:

- Professional services
- Business services (other than professional services)
- Postal and courier services
- Telecommunication services
- Construction and related engineering services
- Distribution services
- Environmental services
- Financial services
- Tourism and travel related services
- News agency services
- Transport services
- Energy services

The EC proposes that Mexico's current GATS commitments are revised in accordance with this request. The EC is both seeking improved commitments

and clarification of existing commitments as set out in this Request. The EC is furthermore looking for a reduction in scheduled limitations whether these are horizontal or sector specific in nature. In doing so, the EC is not seeking the dismantling of public services nor the privatisation of state owned companies.

In conformity with the objectives set out in the EC's overall approach to services negotiations (document S/CSS/W/15), the EC reiterates its commitments to promote regulatory disciplines in accordance with Article VI:4 of the GATS. The EC, however, reserves its right to address at any time to Mexico specific requests concerning regulatory issues.

The EC further requests that commitments are entered in accordance with the scheduling guidelines adopted by the Council of Trade in Services on 23 March 2001 (S/L/92). In particular, for each commitment or limitation entered the EC requests:

- that the sector and sub-sector are clearly identified in accordance with the classification list in Document MTN.GNS/W/120 or other internationally recognised classification (e.g. Financial Services Annex) and corresponding CPC number. If this is not possible, the schedule should contain a sufficiently detailed definition to avoid any ambiguity as to the scope of the commitment. In that respect, the EC would like to recall the classification or list of activities proposed in its negotiating proposals with regard to postal and courier, environmental and energy services. While discussions on classification in these sectors are still ongoing, the EC would like to invite Mexico to present its offer in accordance with this approach.
- that any remaining limitation on market access (hereafter "MA") or on national treatment (hereafter "NT") are clearly described and only be inscribed in the market access or national treatment columns if the measure is of a nature foreseen by Articles XVI-XVII GATS.

The EC remains available to provide any clarification and answer any question on this request. For each service sector, W120 classification has been followed unless expressly indicated and CPCs refer to the Provisional CPC classification. The precise scope for each sector is without prejudice to the EC's final positions on classification issues and to the EC's classification of their existing commitments.*

# HORIZONTAL COMMITMENTS

## EC REQUEST TO MEXICO

### GENERAL

- Mode 3: Foreign investment in activities reserved for Mexican nationals must be through neutral shares, whose purchase must be quoted on the Mexican Stock Exchange. **EC request:** remove such restriction.
- Mode 3: Foreigners may not acquire direct ownership of land and water in a 50 km. strip on the coastline and 100 km. strip along the frontiers. **EC request:** remove such restriction or apply on a national treatment basis.
- Mode 3 – NT: National treatment is unbound for research and development subsidies. **EC Request:** Clarify the applicability and scope of the regime.
- Mode 3 - NT: National treatment is unbound for incentives to small service enterprises owned by Mexican nationals. **EC Request:** commit national treatment for foreign owned small service enterprises

### MODE 4

#### **Intra-corporate transferees**

- The EC requests that a commitment be made to allow as intra-corporate transferees without requiring an economic needs test « persons with a university degree or equivalent technical qualification who are transferring for career development purposes or to obtain training in business techniques or methods ». The maximum prior employment requirement should be one year.

#### **Business Visitors**

- No specific commitment has been made for Business Visitors who are not entering to themselves supply a service, but rather to establish a commercial presence. **EC request:** Make a specific commitment to this effect. Economic needs tests should not be applied. The maximum length of stay should be at least 90 days in any 12 month period.

#### **National Treatment**

- List of activities which are reserved for Mexican nationals. **EC request:** Eliminate.

#### **Contractual Service Suppliers**

- A contractual service supplier is a juridical person with no commercial presence in Mexico, who has obtained a service contract in Mexico which requires the presence of its employees in Mexico in order to fulfil that contract. **EC request:** Take commitments for natural persons employed in the service sectors listed below and seeking temporary entry as contractual service suppliers. Such natural persons can be required to have a university degree or equivalent technical qualification - plus the appropriate professional

qualifications where this is required by domestic law. The length of stay may be limited.

**Additional commitments**

- Difficulties are experienced as a result of the length of time taken to process work permits, as well as the apostilation of documents. The EC wishes to discuss the possibility of taking additional commitments to address this issue.

*Note: Mode 4 is covered horizontally in this part for all service sectors. The sectoral requests in the following pages only refer to mode 4 when specifically related to one particular service sector.*

## **PROFESSIONAL SERVICES**

### **EC REQUEST TO MEXICO**

Mexico has committed this sector only partially. The EC requests that this sector is committed as follows:

#### **A. LEGAL SERVICES (CPC 861)**

This sub-sector is not committed. **EC Request:**

- Commit covering at least consultancy on public international law and on law of jurisdiction where the service supplier or its personnel are qualified lawyers
- Modes 1, 2, 3: Take full commitments, i.e. schedule “none”, under MA and NT
- Mode 4: Commit as referred in the section “Horizontal commitments”

#### **ACCOUNTING, AUDITING AND BOOKKEEPING SERVICES (CPC 862)**

- Mode 3: MA – Conditions on foreign investment. **EC Request:** Remove
- Mode 3: NT – Obligation to use name of Mexican partners. **EC Request:** Remove

In addition, the non-recognition of international accounting standards and restrictions on the payment of fees, royalties and fees abroad have been reported. The EC wishes to discuss the scope of these regulatory trade barriers and the solution to be given to these issues.

#### **C. TAXATION SERVICES**

This sub-sector is not committed. **EC Request:**

- Modes 1, 2, 3: Take full commitments, i.e. schedule “none”, under MA and NT
- Mode 4: Commit as referred in the section “Horizontal commitments”

#### **D. ARCHITECTURAL SERVICES (CPC 8671)**

- Mode 3: MA – Conditions on foreign investment. **EC Request:** Remove

#### **E. ENGINEERING SERVICES (CPC 8672)**

- Mode 3: MA – Conditions on foreign investment. **EC Request:** Remove

#### **F. INTEGRATED SERVICES (CPC 8673)**

**G. URBAN PLANNING AND LANDSCAPE ARCHITECTURAL SERVICES**  
**(CPC 8674)**

Sub-sectors f) and g) are not committed. **EC Request** for each of these two sub-sectors:

- Modes 1, 2, 3: Take full commitments, i.e. schedule “none”, under MA and NT
- Mode 4: Commit as referred in the section “Horizontal commitments”

## **BUSINESS SERVICES (OTHER THAN PROFESSIONAL SERVICES)**

### **EC REQUEST TO MEXICO**

#### **B. COMPUTER AND RELATED SERVICES**

- This sub-sector has only been partially committed. **EC request:** Extend coverage and schedule commitments at the two-digit level as follows:

##### **Computer and Related Services (CPC 84):**

- Modes 1, 2 and 3: Take full commitments, i.e. schedule “none” under MA and NT;
- Mode 4: Commit as referred to in the horizontal section.

#### **C. RESEARCH AND DEVELOPMENT SERVICES**

- a) **R&D Services on natural sciences (CPC 851),**
- b) **R&D Services on social sciences and humanities (CPC 852) and**
- c) **Interdisciplinary R&D services. (CPC 853)**

Mode 3: MA – FDI limited up to 49% of registered capital. **EC request:** Eliminate this requirement for privately financed Research and Development.

#### **D. REAL ESTATE SERVICES**

Mexico has not committed this Sector. The EC requests that it be committed as follows:

- a) **Involving own or leased property (CPC 821)**
- b) **On a fee or contract basis (CPC 822)**

For each of the above sub-Sectors:

- Modes 1, 2, 3: Take full commitments, i.e. schedule "none" under MA and NT.
- Mode 4: Commit as referred to in the section "Horizontal commitments".

#### **E. RENTAL AND LEASING SERVICES WITHOUT OPERATORS**

##### **a) Relating to ships (CPC 83103)**

- Mode 1: MA and NT – This Mode remains unbound. **EC request:** Take full commitments, i.e. schedule “none” under MA and NT.
- Mode 3: MA – FDI limited up to 49% of registered capital. **EC request:** Eliminate.

### **c) Relating to other transport equipment (CPC 83101 + 83102 + 83105)**

This sub-sector has not been committed for CPCs 83102 or 83105. **EC request:** Extend sectoral coverage to these CPCs as follows:

- Modes 1, 2, 3: Take full commitments, i.e. schedule "none" under MA and NT.
- Mode 4: Commit as referred to in the section "Horizontal commitments".

#### **For CPC 83101**

- Mode 3: MA – FDI limited up to 49% of registered capital. **EC request:** Eliminate.

### **d) Relating to other machinery (CPC 83106 – 83109)**

For CPC 83106, 83108 and 83109: Mode 3: MA – FDI limited up to 49% of registered capital. **EC request:** Eliminate.

For CPC 83107: Mexico has not committed these sub-Sectors. The EC requests that they be committed as follows:

- Modes 1, 2, 3: Take full commitments, i.e. schedule "none" under MA and NT.
- Mode 4: Commit as referred to in the section "Horizontal commitments".

## **F. OTHER BUSINESS SERVICES**

*NB: Requests (if any) on (h) - services incidental to mining, and (j) - services incidental to energy distribution, are covered in those sections of the request dealing with Energy Services and Construction Services.*

### **a) Advertising (CPC 871)**

Mode 3: MA – FDI limited up to 49% of registered capital. **EC request:** Eliminate.

### **b) Market research and Public Opinion Polling (CPC 864)**

- Mode 1: MA – unbound. **EC request:** Take full commitment scheduled as “none”.

### **d) Services related to management consulting (CPC 866)**

- In contrast to W 120 Mexico assigns “Administrative formalities and collection services” to CPC 866. **EC request:** Please clarify the situation. Should the commitments scheduled under CPC 866 apply to services related to management consulting, eliminate the foreign equity ceiling, and take full commitments in Mode 1 NT.

### **e) Technical testing and analysis services (CPC 8676)**

Mexico has not committed this sub-Sector. The EC requests that it be committed as follows:

- Modes 1, 2, 3: Take full commitments, i.e. schedule "none" under MA and NT.
- Mode 4: Commit as referred to in the section "Horizontal commitments".

**k) Placement and supply services of personnel (CPC 872)**

- Mode 1: MA and NT – This Mode remains unbound. **EC request:** Take full commitments, i.e. schedule “none” under MA and NT.
- Mode 3: MA – FDI limited up to 49% of registered capital. **EC request:** Eliminate.

**l) Security Services (CPC 87302 – 87309)**

- Mode 3: MA - FDI limited up to 49% of registered capital. **EC request:** Eliminate.

**m) Related scientific and technical consulting services (CPC 8675)**

Mexico has not committed this sub-Sector. The EC requests that it be committed as follows:

- Modes 1, 2, 3: Take full commitments, i.e. schedule "none" under MA and NT.
- Mode 4: Commit as referred to in the section "Horizontal commitments".

**n) Maintenance and Repair of Equipment (not including transport equipment) (CPC 633 + 8861-8866)**

Mexico has made no commitments for CPC 633, 8861, 8863-8865. **EC request:**

- Modes 1, 2, 3: Take full commitments, i.e. schedule "none" under MA and NT.
- Mode 4: Commit as referred to in the section "Horizontal commitments".

**For CPC 8862 and 8866:**

- Mode 3: MA – FDI limited up to 49% of registered capital. **EC request:** Eliminate.

In contrast to W 120 Mexico assigns “Repair and maintenance of machinery and equipment for general use, not assignable to any specific activity” to CPC 886. **EC request:** Clarification. The EC reserves the right to make a request in the this sub-sector following clarification from Mexico.

**o) Building cleaning services (CPC 874)**

Mexico has not committed this sub-sector. **EC Request:**

- Mode 3: take full commitments, i.e. schedule “none” under MA and NT
- Mode 4: Commit as referred to in the section “Horizontal commitments”

**p) Photographic Services (CPC 875)**

Mexico has made no commitments for CPC 87501-87504 and 87507-87509: **EC request:**

- Modes 1, 2, 3: Take full commitments, i.e. schedule "none" under MA and NT.
- Mode 4: Commit as referred to in the section "Horizontal commitments".

**For CPC 87505 and 87506:**

- Mode 3: MA – FDI limited up to 49% of registered capital. **EC request:** Eliminate.

**q) Packaging Services (CPC 876)**

Mexico has not committed this sub-Sector. The EC requests that it be committed as follows:

- Modes 1, 2, 3: Take full commitments, i.e. schedule "none" under MA and NT.
- Mode 4: Commit as referred to in the section "Horizontal commitments".

**r) Printing and Publishing Services (CPC 88442)**

Mexico has not committed this sub-Sector. The EC requests that it be committed as follows:

- Modes 1, 2, 3: Take full commitments, i.e. schedule "none" under MA and NT.
- Mode 4: Commit as referred to in the section "Horizontal commitments".

**s) Convention Services (part of CPC 87909)**

Mexico has not committed this sub-Sector. The EC requests that it be committed as follows:

- Modes 1, 2, 3: Take full commitments, i.e. schedule "none" under MA and NT.
- Mode 4: Commit as referred to in the section "Horizontal commitments".

**t) Translation Services (CPC 87905)**

Mexico has not committed this sub-Sector. The EC requests that it be committed as follows:

- Modes 1, 2, 3: Take full commitments, i.e. schedule "none" under MA and NT.
- Mode 4: Commit as referred to in the section "Horizontal commitments".

**Grounds maintenance (part of CPC 88110) and**

**Washing and Cleaning Services (CPC 97011)**

Mexico has not committed these two sub-sectors. **EC Request:**

- Mode 3: Take full commitments, i.e. schedule “none” under MA and NT
- Mode 4: Commit as referred to in the section “Horizontal commitments”

# POSTAL AND COURIER SERVICES

## EC REQUEST TO MEXICO

Mexico has only partially committed this sector (commitments in courier services). This request is based on the EC proposal for the classification of postal and courier services. While discussions on classification in this sector are still ongoing, the EC would like to invite Mexico to present its offer in accordance with this proposal, without prejudice to the outcome of the discussion on the classification of postal and courier services:

### **SERVICES RELATING TO THE HANDLING<sup>1</sup> OF POSTAL ITEMS<sup>2</sup>, WHETHER FOR DOMESTIC OR FOREIGN DESTINATIONS:**

**A. Handling of addressed written communications on any kind of physical medium<sup>3</sup>, including:**

- Hybrid mail services
- Direct mail

**B. Handling of addressed parcels and packages<sup>4</sup>**

**C. Handling of addressed press products<sup>5</sup>**

**D. Handling of items referred to in A. to C. above as registered or insured mail.**

**E. Express delivery services<sup>6</sup> for items referred to in A. to C. above**

**F. Handling of non-addressed items**

**G. Document exchange**

**H. Other services not elsewhere specified**

For sub-sectors B., C., E., F. and G.:

- Modes 1, 2 and 3: Undertake full commitments for market access and national treatment.
- Mode 4: Commit as referred to in the section « Horizontal commitments ».

For sub-sectors A. and D.:

- Modes 1, 2 and 3: Undertake commitments for market access and national treatment.
- Mode 4: Commit as referred to in the section « Horizontal commitments ».

**Mexico's current commitments:**

Market access:

- Mode 1: « Unbound». **EC request:** Schedule « None ».
- Mode 3: « Foreign investment up to 49 % of the registered capital of enterprises. Requirements laid down for each specific means of transport must be fulfilled ». **EC request:** Delete the restriction, schedule « None ».

National treatment:

- Mode 1: « Unbound ». **EC request:** Schedule « None ».

# TELECOMMUNICATION SERVICES

## EC REQUEST TO MEXICO

Mexico has only partially committed this Sector. The EC requests that this Sector is committed as follows:

### ALL MODES

Mexico defines “value added services” as: telecommunication services which utilize computerized processing systems that: a) affect the format, content, protocol or similar aspects of the information transmitted to the user; b) give the client additional, different or restructured information; or c) involve interaction between the user and the information stored. **EC request:** explain if this covers Electronic mail, Voice mail, On-line information and data base retrieval, electronic data interchange (EDI), enhanced/value-added facsimile services, incl. store and forward, store and retrieve, code and protocol conversion? Also explain if it covers other services?

There are no commitments on telex and telegraph services. **EC request:** Make full commitments in these sub-sectors, i.e. schedule “None”.

Commitments on basic telecommunications are valid only for facilities-based services. **EC Request:** remove this restriction.

Telecomunicaciones de Mexico has exclusive rights to links with Intelsat and Inmarsat. **EC Request:** remove this restriction.

### MODE 1 – CROSS-BORDER SUPPLY

For value-added services, the schedule states that “A permit is required in order to provide services using radio-electric space” and “A permit from the Ministry of Communications and Transport (SCT) is required in order to establish private networks and supply value-added services”. **EC Request:** remove these provisions.

For value-added services, the central equipment and systems for providing special telecommunication services must be located in Mexican territory. **EC Request:** remove this provision.

For other telecommunications services, International traffic must be routed through the facilities of an enterprise that has a concession granted by the Ministry of Communications and Transport (SCT). **EC Request:** remove this provision.

### **MODE 3 - ESTABLISHMENT**

There is a 49% equity cap on foreign investment. **EC Request:** remove this ceiling.

For value-added services, there is a provision that Thirty per cent of excess capacity of private circuits may be rented or sold. **EC Request:** remove this restriction.

For value-added services, long-distance services for third users are prohibited. **EC Request:** remove this prohibition.

For value-added services, the schedule states that “A permit is required in order to provide services using radio-electric space”. **EC Request:** remove this provision as it should not affect market access or national treatment.

For value-added services, the schedule states that “A permit from the Ministry of Communications and Transport (SCT) is required in order to establish private networks and supply value-added services”. **EC Request:** remove this provision as it should not affect market access or national treatment.

For value-added services, the schedule states that “A permit from the SCT is required for cross-border connections”. **EC Request:** remove this provision as it should not affect market access or national treatment.

For value-added services, there is a provision in the schedule about an exclusive provider of computerized airline reservation services. **EC Request:** remove this provision.

For telecommunications services, the schedule states that “A concession (i.e. the granting of title to install, operate or use a facilities-based public telecommunications network.) from the SCT is required” and that “Only enterprises established in conformity with Mexican law may obtain such a concession”. **EC Request:** remove these provisions as they should not affect market access or national treatment.

# CONSTRUCTION AND RELATED ENGINEERING SERVICES

## EC REQUEST TO MEXICO

### GENERAL

Mexico has committed this Sector only partially. The EC requests that this Sector be committed as follows:

### ALL SUB-SECTORS (CPC 511 to CPC 518)

Mode 3: MA – Restriction on foreign investment of 49% of the registered capital of enterprises. **EC Request:** Remove this restriction.

### A. GENERAL CONSTRUCTION WORK FOR BUILDINGS (CPC 512)

This sub-sector is not committed for CPC 5123 (construction work for warehouses and industrial buildings), for CPC 5125 (construction work for public entertainment buildings) and for CPC 5126\_ (construction work for hotel, restaurant and similar buildings).

**EC Request** for these CPCs:

- Mode 3: Take full commitments, i.e. schedule “none” under MA and NT.
- Mode 4: Commit as referred in the section “Horizontal commitments”.

### B. GENERAL CONSTRUCTION WORK FOR CIVIL ENGINEERING (CPC 513)

This sub-sector is only partly committed. **EC Request:**

Extend commitments coverage to the whole sub-sector CPC 513 and schedule:

- Mode 3: “none” under MA and NT.
- Mode 4: Commit as referred in the section “Horizontal commitments”.

### C. INSTALLATION AND ASSEMBLY WORK (CPC 514+516)

This sub-sector is not committed for CPC 514 (assembly and erection of prefabricated constructions) and is committed only for parts of CPC 516 (installation work). **EC Request:** commit the entirety of CPC 514 and 516 as follows:

- Mode 3: Take full commitments, i.e. schedule “none” under MA and NT.
- Mode 4: Commit as referred in the section “Horizontal commitments”.

### D. BUILDING COMPLETION AND FINISHING WORK (CPC 517)

This sub-sector is defined as “Building completion and finishing work”. **EC Request:** Refer explicitly to “CPC 517”

### **E. OTHER (CPC 511+515+518)**

This sub-sector is not committed for CPC 518 (renting services related to equipment for construction or demolition of buildings or civil engineering works, with operator): and is committed only for parts of CPC 511 (pre-erection work at construction sites) and CPC 515 (special trade construction work). **EC Request:** commit the entirety of CPC 511, 515 and 518 as follows:

- Mode 3: Take full commitments, i.e. schedule “none” under MA and NT.
- Mode 4: Commit as referred in the section “Horizontal commitments”.

## **DISTRIBUTION SERVICES**

### **EC REQUEST TO MEXICO**

Mexico has only partially committed this Sector. The EC requests that this Sector is committed as follows:

#### **A. COMMISSION AGENTS' SERVICES (CPC 621, 6111+6113+6121)**

This sub-sector is not committed. **EC Request:**

- Modes 1, 2, 3: Take full commitments, i.e. schedule "none".
- Mode 4: Commit as referred in the section "Horizontal commitments".

#### **B. WHOLESALE TRADE SERVICES (CPC 622, 6111+6113+6121)**

The distribution of agricultural raw materials and live animals (CPC 6221) is not committed (except for animal seed). **EC Request:**

- Modes 1, 2, 3: Take full commitments for the distribution of raw materials, i.e. schedule "none".
- Mode 4: Commit as referred in the section "Horizontal commitments".

#### **C. RETAILING SERVICES (CPC 631+632, 6111+6113+6121+613)**

- 1<sup>st</sup> indent (Food products): It is not clear whether the distribution of beverages and tobacco by supermarkets, self-service stores and shops is committed. It is also not clear whether "department stores" are included under "supermarkets". **EC Request:** Merge the first two indents and leave the sector definition as follows: "Retail sales of food, beverages and tobacco (CPC 6310)".
- 2<sup>nd</sup> indent (Food products): Trade-union and cooperative stores do not allow foreign investment. **EC Request:** Clarify the scope of such restriction.
- 3<sup>rd</sup> indent (Non-food products under CPC 632): It is not clear whether "department stores and shops" includes all "non-specialized establishments". It is not clear whether "specialized establishments" can distribute non-food products. **EC Request:** Remove "in department stores and shops".
- 3<sup>rd</sup> indent (Non-food products under CPC 632): Trade-union and cooperative stores do not allow foreign investment. **EC Request:** Clarify the scope of such restriction.
- 4<sup>th</sup> indent (Motor vehicles): CPCs 6113, 6121 and 613 are missing to match the description of the sub-sector. **EC Request:** include such CPCs codes.
- 5<sup>th</sup> indent (Non-food products under CPC 6329): The distribution of various types of combustible (liquid gas, coal, gasoline ...) is not committed when distributed by "specialized establishments". **EC Request:** Remove such restriction.
- 5<sup>th</sup> indent (Non-food products under CPC 6329): Trade-union and cooperative stores do not allow foreign investment. **EC Request:** Clarify the scope of such restriction.

#### **D. FRANCHISING SERVICES (CPC 8929)**

This sub-sector is not committed. **EC Request:**

- Modes 1, 2, 3: Take full commitments, i.e. schedule "none".
- Mode 4: Commit as referred in the section "Horizontal commitments".

# **ENVIRONMENTAL SERVICES**

## **EC REQUEST TO MEXICO**

Mexico has not undertaken commitments in environmental services. This request is based on the EC proposal for the classification of environmental services. While discussions on classification in this sector are still ongoing, the EC would like to invite Mexico to present its offer in accordance with this proposal, without prejudice to the outcome of the discussion on the classification of environmental services:

### **A. WATER FOR HUMAN USE & WASTEWATER MANAGEMENT**

#### **Water collection, purification and distribution services through mains, except steam and hot water**

This sub-sector only concerns the distribution of water ‘through mains’ (i.e. urban sewage systems). This excludes any cross-border transportation either by pipeline or by any other means of transport, nor does it imply access to water resources.

- Mode 3: Take commitments under MA and NT
- Mode 4: Commit as referred to in the section “Horizontal commitments”

#### **Waste water services (CPC 9401)**

- Mode 3: Take full commitments, i.e. schedule “none” under MA and NT

#### INSURANCE

- Mode 3: MA – In direct insurance (life and non-life), reinsurance and services auxiliary to insurance, various ceilings on foreign aggregate and individual shareholding. **EC Request:** Eliminate all these caps.
- Mode 3: MA and NT – Direct branching is not allowed. **EC Request:** Commit direct branching
- Modes 1 and 2: MA and NT – MAT insurance s not committed. **EC Request:** Take full commitments in accordance with the Understanding.
- Modes 1 and 2: MA and NT – No commitment has been taken on cross-border insurance of larger non-MAT risks. **EC Request:** Take commitments on insurance of larger risks, based on a definition to be determined in negotiations and accompanied by appropriate prudential regulations adopted by the regulatory authorities of the host country and protecting policy-holders, avoiding discrimination between operators, in line with the principles agreed in the OECD Framework for Insurance Market Liberalisation.
- Modes 1 and 2: MA and NT – In reinsurance, discretionary registration in mode 1 and unbound in mode 2. **EC Request:** Take full commitments, i.e. schedule “none”.
- Modes 1: NT – Existence of an excise tax on reinsurance premiums ceded abroad. **EC Request:** “None” has been scheduled, but EU industry raises this issue. Please explain.
- Modes 1 and 2: MA and NT – Unbound in services auxiliary to insurance, such as insurance broking and agency services. **EC Request:** Take full commitments on intermediation of MAT insurance and of reinsurance in accordance with the Understanding, and on other services auxiliary to insurance, such as consultancy, actuarial, risk assessment and claim settlement services.

## **BANKING AND OTHER FINANCIAL SERVICES**

- The following subsectors are not committed: payment and money transmission services, trading for own account or for account of customers of derivative products, exchange rate and interest rate instruments, settlement and clearing services for financial assets, and provision and transfer of financial information. **EC Request:** Take full commitments in modes 1, 2 and 3 for provision and transfer of financial information, in modes 2 and 3 for the other subsectors and commit as referred to in the section “Horizontal commitments” in mode 4.
- Mode 3: MA – Ceilings on foreign shareholding in financial leasing companies, foreign exchange firms, investment companies, pension fund management companies, credit information companies, investment consultants and holding companies, and ceilings on individual holdings in banks, financial leasing companies, securities firms, foreign exchange firms, investment companies, pension fund management companies, credit information companies, investment consultants and holding companies. **EC Request:** Eliminate all these caps.
- Modes 1 and 2: MA and NT – Unbound in all subsectors (except re-guarantee institutions). **EC Request:** Take full commitments in modes 1 and 2 for advisory and other auxiliary financial services, and in mode 2 for the other subsectors.
- Mode 3: MA – Direct branching is not committed. **EC Request:** Commit direct branching
- Mode 3: MA – Foreign investment is not allowed in credit union, savings and loans companies and development banking institutions. **EC request:** Remove these limitations.

# **TOURISM AND TRAVEL RELATED SERVICES**

## **EC REQUEST TO MEXICO**

Mexico has committed this sector only partially. The EC requests that it be committed as follows:

- Mode 3: Market access: Remove entry regarding the need to hold a licence for hotel and restaurant services. If there are restrictions on the number of licences given, schedule accordingly.
- Remove restriction of 49% for foreign investment in enterprises providing restaurant services (CPC 642), and for cabarets and night clubs (CPC 6432)
- Mode 4: Commit as referred to in the section “Horizontal commitments”

### **B. TRAVEL AGENCIES AND TOUR OPERATORS SERVICES (CPC 7471)**

- Mode 1: Market access and national treatment: Bind this mode, and undertake full commitments.
- Mode 3: Market access: Remove entry regarding the need to hold a licence for travel agencies and tour operators.

# TRANSPORT SERVICES

## EC REQUEST TO MEXICO

### A. MARITIME TRANSPORT

Mexico has no commitments for maritime transport.

**EC request:** Take commitments in accordance with the attached model schedule (Annex 1). In particular for the following areas:

- 1) **International transport (freight and passengers) CPC 7211 and 7212**
- 2) **Additional commitments for access to and use of ports facilities**
- 3) **Maritime auxiliary services (maritime cargo handling, storage and warehouse services, customs clearance services, container station and depot services, maritime agency services)**
- 4) **Multimodal activities: for inland forwarding of cargoes - commit the ability to rent or lease - or to have access to and use of multimodal facilities (as specified in the note to the schedule).**
- 5) **Definitions – commit definitions as specified in the model schedule.**

The EC also request the following additional maritime commitments from Mexico:

- 6) **Equipment.** To facilitate planning of their businesses operators should be allowed to reposition their own equipment, such as empty containers, between ports of Mexico, when it is not carried against payment. This is requested to be committed in a new footnote:

*“9. Movement of own equipment. International maritime transport suppliers can move/reposition their own equipment (i.e. empty containers, flatbeds etc.) on their own vessels between ports of Mexico.”*

- 7) **International cargo.** With the development of containerisation and high frequency networking services and with the ever-larger vessels having to limit direct port calls for physical or economic reasons, the feeding of cargoes between main ports and way ports is becoming more important as an integral part of efficient international maritime transport. An international maritime transport supplier should be allowed to operate feeder services for its own international cargo between ports of Mexico. This is requested to be committed in a new footnote:

*“10. International maritime transport suppliers can operate vessels of any flag for the purpose of pre- and onward carriage of the international cargo between ports of Mexico.”*

In this context Mexico may wish to take the one or more of the following principles into concern:

- Size of the port. Only valid for international cargo relayed between national ports handling more than [25.000 TEU] on an annual basis.
- Binding existing ad hoc practices. To the extent exceptions are already granted for use of foreign flagged vessels such practices could be bound to explicitly cover pre- and onward carriage of international cargo.
- Geographical limitations: Transport of international cargo between ports within the same state [or other relevant regional entity] remains excluded.

A final request related to maritime transport is:

**8) Rental and leasing of vessels with crew (CPC 7213, 7223).**

**EC request:**

- Modes 1, 2 and 3: Take full commitments, i.e. schedule “none”, under MA and NT
- Mode 4: Commit as in horizontal commitments.

## NOTE TO THE SCHEDULE

Where road, rail, inland waterways (and) (related) (auxiliary) services are not otherwise fully covered in (this) (a Member's) schedule, a multimodal transport operator (as defined below - 3) shall have the ability to rent or lease trucks, railway carriages or barges and related equipment, for the purpose of inland forwarding of cargoes, or have access to, and use of, these forms of multimodal activities on reasonable and non-discriminatory terms and conditions for the purpose of carrying out multimodal transport operations. (« Reasonable and non-discriminatory terms and conditions» means, for the purpose of (multimodal transport operations), (this additional commitment), the ability of the multimodal transport operator to arrange for the conveyance of its merchandise on a timely basis, including priority over other merchandise which has entered the port at a later date).

### **DEFINITIONS**

1. Without prejudice to the scope of activities which may be considered as «cabotage» under the relevant national legislation, this schedule does not include «maritime cabotage services », which are assumed to cover transportation of passengers or goods between a port located in ... [name of country] ... and another port located in ... [name of the country], traffic originating and terminating in the same port located in [name of country] provided that this traffic remains within ... [name of country]'s territorial waters and transportation of passengers and goods between a port located in ... [name of the country] ... and installations or structures situated on the continental shelf of [name of the country].

2. « Other forms of commercial presence for the supply of international maritime transport services » means the ability for international maritime transport service suppliers of other Members to undertake locally all activities which are necessary for the supply to their customers of a partially or fully integrated transport service, within which the maritime transport constitutes a substantial element. (This commitment shall however not be constituted as limiting in any manner the commitments undertaken under the cross-border mode of delivery).

These activities include, but are not limited to:

- (a) marketing and sales of maritime transport and related services through direct contact with customers, from quotation to invoicing, these services being those operated or offered by the service supplier itself or by service suppliers with which the service seller has established standing business arrangements;
- (b) the acquisition, on their own account or on behalf of their customers (and the resale to their customers) of any transport and related services, including inward transport services by any mode, particularly inland waterways, road and rail, necessary for the supply of the integrated services;
- (c) the preparation of documentation concerning transport documents, customs documents, or other documents related to the origin and character of the goods transported;
- (d) the provision of business information by any means, including computerised information systems and electronic data interchange (subject to the provisions of the annex on telecommunications);
- (e) the setting up of any business arrangements (including participation in the stock of a company) and the appointment of personnel recruited locally (or, in the case of foreign personnel, subject to the horizontal commitment on movement of personnel) with any locally established shipping agency;
- (f) acting on behalf of the companies, organising the call of the ship or taking over cargoes when required.

3. « Multimodal transport operators » means the person on whose behalf the bill of lading /multimodal transport document, or any other document evidencing a contract of multimodal carriage of goods, is issued and who is responsible for the carriage of goods pursuant to the contract of carriage.

4. « Maritime cargo handling services » means activities exercised by stevedore companies, including terminal operators, but not including the direct activities of dockers, when this workforce is organised independently of the stevedoring or terminal operation companies. The activities covered include the organisation and supervision of:

- the loading/ discharging of cargo to/from a ship;
- the lashing/unlashing of cargo;
- the reception/ delivery and safekeeping of cargoes before shipment or after discharge

5. « Customs clearance services » (alternatively « customs house brokers' services ») means activities consisting in carrying out on behalf of another party customs formalities concerning import, export or through transport of cargoes, whether this service is the main activity of the service provider or a usual complement of its main activity.

6. « Container station and depot services » means activities consisting in storing containers, whether in port areas or inland, with a view to their stuffing/ stripping, repairing and making them available for shipments.

7. « Maritime agency services » means activities consisting in representing within a given geographic area, as an agent the business interests of one or more shipping lines or shipping companies, for the following purposes:

- marketing and sales of maritime transport and related services from quotation to invoicing, and issuance of bills of lading on behalf of the companies, acquisition and resale of the necessary related services, preparation of documentation, and provision of business information;
- acting on behalf of the companies organising the call of the ship or taking over cargoes when required.

8. « Freight forwarding services » means (the activity consisting of organising and monitoring shipment operations on behalf of shippers, through the acquisition of transport and related services, preparation of documentation and provision of business information)..

## **ANNEX 2 FACILITATING AIR TRANSPORT SERVICES**

### **Ground-handling Services**

Efficient ground-handling is essential to the proper functioning of air transport and competition between operators in this area ensures that proper use is made of air transport infrastructure. It helps reduce the operating costs of airlines and improves the quality of service for airport users.

For specialised groundhandling suppliers the following activities are requested:

Ground Administration – supervision and administration at the airport (CPC 7461);  
Passenger Handling – assisting arriving, departing and transfer passengers (CPC 7461);  
Baggage Handling – handling baggage in the sorting area (CPC 7461);  
Freight and Mail Handling – physical handling of freight and mail, dealing with security and customs procedures (CPC 74110 (container handling services) and 74190 (other cargo handling services);  
Ramp Handling – marshalling and moving the aircraft, loading and unloading of aircraft, transport of passengers, freight, supplies (CPC 7469).  
Aircraft Services – cleaning the aircraft, heating and cooling, removal of snow and ice (CPC 7469);  
Fuel and Oil Handling – organisation and provision of fuel and oil;  
Aircraft Maintenance – covered specifically by the Annex as above;  
Flight Operations and Crew Administration – preparation of the flight, inflight and post-flight assistance, crew administration;  
Surface Transport – organisation and execution of transport within airport – except to and from aircraft;  
Catering Services – administration, storage, preparation and delivery of bar and food supplies (CPC 6423). [Catering is listed for only for information purposes as this activity is classified and committed by Mexico as part of tourism services]

### **Airport management services**

Airport management services constitute the core activities of airport services providers and cover: Airport operation services (excl. cargo handling), including passenger air terminal services and ground services on air fields, including runway operating services, on a fee or contract CPC 74610. Activities are also related to “other management consulting services” (CPC 86509) and activities separately specified under “other management services not elsewhere classified”(CPC 86609). A commitment will allow services suppliers to take an equity stake in - and engage in the overall operation and management of - airports when these are open for investments from private operators. Thereby it will bind existing common practices in the sector.

# ENERGY SERVICES

## EC REQUEST TO MEXICO

This request includes services that are listed under the negotiating proposal of the EC (S/CSS/W/60). The work on the classification of these services is still underway. For this reason, some activities therefore lacks reference to CPC.

The EC wishes to underline the significant contribution of an appropriate use of energy for the promotion of sustainable development.

The EC requests that this area is committed as follows:

### **A. SERVICES RELATED TO EXPLORATION AND PRODUCTION**

#### **CPC 883: Services incidental to mining**

This sub-sector is not committed. **EC Request:**

- Mode 3: Take full commitments, i.e. schedule "none".
- Mode 4: Commit as referred in the section "Horizontal commitments".
